RE: Opening of Memorial Park washrooms during 2014 Salmon Run

#### **BACKGROUND:**

Council requested investigate the feasibility of having the Memorial Park washrooms open for the weekends during the 2014 Salmon Run (September 26 to October 26).

#### **DISCUSSION:**

Public Works has informed Administration that typically the washrooms are closed at the end of September as water is blown from the pipes in the first week of October. It is not unusual to have a frost quite early in that month. It is their observation that there are few visitors to the park at that time of year as the boat launch is inaccessible.

Public Works will be able have the washrooms kept open the weeks of September 26 / 27 and October 4 / 5. This will not occur any additional cost for staff time.

#### **RECOMMENDATION:**

Proceed to have the washrooms at Memorial Park kept open an additional 2 weekends (September 26 / 27 and October 4 / 5).

This flyer is to inform you of a proposed reduction in service at the Chase Post Office. Canada Post plans to cut the hours of service to you, the public, opening later each weekday morning and <u>eliminating the Saturday hours of service</u>. In some communities, Saturday is only day available for some to do their postal business. We need to know if this is true for you. The proposed new hours of operation are Mon., Tues, Wed. & Fri. 9:00-5:00 and Thurs. 9:00-6:00.

If these reductions are implemented, there will be a negative impact on the services as well as the earnings of the affected employee, as this reduction is eliminating a part-time position from your community. If Canada Post changes the opening times of the office, it will limit the times that businesses will be able to obtain their parcels or do postal business. For some the morning or Saturday is the only time they have to get to the Post Office. This change will affect members of the community who work outside of the town and use this time to get to the Post Office. This service reduction will decrease your access to pick up or mail parcels, buy or cash money orders, pick up call for items, such as registered letters, Xpresspost or purchase postal products, etc.

Canadian Postmasters and Assistants Association (CPAA) is the union which represents Canada Post employees in rural Canada.

CPAA is not in favour of a reduction in postal service to your community, but we need your support.

Canada Post has recently announced its plan to pursue the privatization of Postal Outlets. Corporate Post Offices staffed by CPAA members have a proven record of providing responsible, professional and consistent service. CPAA Post Offices are staffed by trained, competent and reliable employees. CPAA members have the ability to meet the needs of the communities we serve. We know and understand our communities and have earned the trust and respect of our neighbours.

We know that rural Canadians rely on their postal service. Should Rural Canadians be expected to tolerate a reduced level of Postal Service? We urge you to take up the cause and insist that the Federal Government halt the steady erosion of postal service in our Rural Communities. As a Federal Crown Corporation, Canada Post takes direction from our Federal Government. Let your MP, Colin Mayes, know that you are not in favour of a reduction in your postal service. We want to see that your community's postal service is not reduced. Please share your opinions with your MP, CPAA and Canada Post Customer Service 1-800-267-1177.

**RE:** Aylmer Road Business Owners' Meeting August 27, 2014

Suggestions to Improve Traffic and Aesthetics of Properties

A meeting of several Aylmer Road business owners/operators was held in Council Chamber on August 27, 2014. The following issues were raised:

- People walk through the area and there is no designated walking path/lane for them;
- People drive through the area very quickly, not heeding slow moving vehicles and other vehicles that are being utilized for businesses along Alymer;
- Vehicle traffic is sometimes very inconsiderate of larger vehicles moving into and out of business properties;
- The stop sign at Aylmer and VLA is not regularly adhered to, and one of the signs is in a location that causes problems for sightlines;
- People complain about the industrial area being 'messy' if the area were designated Industrial Park, and the public educated that this area is indeed industrial and also requires slower vehicle speeds, there may be a reduction in complaints;
- Every business owner/operator needs to take some resonsibility for their land and the condition of their property if everyone pitches in, the businesses and the Village can show the public at large that both are working together to enhance the industrial park and to help promote business;
- Often people do not know where to go to attend one or more of the businesses in the area

   better signage would go a long way to direct people to the business that they wish to
   patronize.

#### Tasks to be pursued:

- Develop signage for both the Shuswap Avenue end and the VLA end of the Industrial Area:
- Look into land use and whether designation of the area as Industrial Park will be of benefit to the existing and future businesses in the area;
- Install 4-way stop at corner of Aylmer and VLA and reorient some of the existing stop signs for better vehicle sightlines;

- Begin to educate the public via Sunflower articles that the area is industrial;
- Place speed signs into area that denote 30km per hour, and include "slow moving vehicles" on signage to warm regular traffic of larger machinery, trucks, large vehicles entering and exiting properties in the area;
- Investigate the usage of the road right of way by various businesses and ensure they are not utilizing the road right of way for parking for long periods of time.
