**4. DELEGATIONS**

Chairperson Egely welcomed Lynne Moyer and handed her the floor to discuss her concerns regarding Pine Street traffic. Mrs Moyer noted a few amendments to the spreadsheet provided as part of the Agenda package regarding the direction the electronic signage was facing during the review. She noted John Mackenzie did an excellent job using the speed gun and moving the sign to conduct the research. She also thanked Brian Stroud for providing the sign.

Mrs Moyer is requesting Council find a permanent solution for the traffic issues along Pine Street. She received correspondence from a representative from the Ministry of Transportation & Infrastructure advising that the Ministry has no jurisdictional authority over Pine Street. <A copy of this correspondence is now part of the public record as is the report written by Mrs Moyer>

Mrs Moyer understands citizen may only offer suggestions but hopes this Council will take into consideration the effect these traffic issues may have on public safety. She provided a

number of statistics regarding the number of homes in the area and noted the road is used not only for residents to get to their properties but by those wishing to access the golf course, boat launch, RV campground and to properties that are over the river. She also mentioned that there are issues with bicycles on the sidewalk and that perhaps regular signage could be put in place or painted on the roadway.

Mayor Berrigan thanked Mrs Moyer for her presentation and noted he understands her concerns but speeds are the responsibility of the RCMP to monitor.

Opportunity for the Public to Discuss Municipal Matters

The following is a point form breakdown of the opinion of citizens.

Ellen Blackburn

- Pine Street is different from other streets as residents back out of their driveway onto a very busy street.
- Situation could be resolved with either stop signs or speed humps at each end to slow traffic.
- A reduced speed limit would be of benefit throughout the Village.

Don Davies

- Pine Street is extremely busy.
- Kelowna has an electronic speed limit sign and perhaps they could be contacted to see if that method works.

Ingrid Whalley

- Residents from Adams Lake Indian Band and the farms across the bridge use Pine Street as a secondary highway.

Russ Rowe

- Kamloops installed roundabouts which is cheaper than traffic lights and more effective than stop signs.

Craig Achtree

- Electronic signage and police monitoring of speed works.
- Place 4-way stop sign at Pine Street and 4<sup>th</sup> Avenue as it is the halfway point.

Ellen Blackburn

- Something needs to be done to slow traffic coming off of bridge.

Don Davies

- The sidewalk cannot be used when it rains as vehicles go by so fast the puddles splash pedestrians.

Mayor Berrigan noted that they take these concerns very seriously and Council will strive to find a fiscally responsible and safe solution.

Rosemary Derksen

- Recently moved to Chase from Victoria and finds Pine Street very quiet compared to the “quiet” street she lived on previously.
- In her experience speed humps or bumps do not work but traffic circles and 4-way stops are effective.

John Stadnyck

- Lives on the most dangerous corner in Chase where vehicles come flying over the bridge.
- In favour of having a roundabout as it forces vehicles to slow down.
- Worried about the children in the playground as sometimes they don't think about safety and run into the road.

Fred Einarson

- As residents of Pine Street cannot back out of their driveways perhaps they would be able to have two access points and it would be safer to simply drive out.

Lynne Moyer

- Is in favour of a roundabout and thinks it could work at the intersection of Pine Street and 4<sup>th</sup> Avenue.

Kelly Erickson

- Is in favour of a 4-way stop at Pine Street and 3<sup>rd</sup> Avenue as it would provide for a natural crossing.

Don Davies

- Queried the reason behind a 30 km/hr speed limit and 4-way stop on Aylmer Road. Was told it came about because of a situation like this where residents complained.

Bev Iglesias

- Requested the current policy of granting all grant-in-aid / waiver requests at 50% be reviewed and that requests be evaluated on a case by case basis. Many of the organizations that approach Council are run by volunteers who are simply trying to give back to the community by hosting events free or on a cost-recovery basis. The pie

fundraiser volunteers put in countless hours to raise over \$9,000 which was given back to the Village for installation of a new stove and flooring in the Community Hall.

Rick Apted

- Has had experience with losing volunteers who are just trying to do good things for their community but are worn out. Suggested Council review their policy for waivers, compile a list of who needs help and have information distributed.
