7. UNFINISHED BUSINESS

7.1 Reconsideration of Pine Street Stop Sign Placement

At its Regular meeting of October 27, 2015, the following resolution was passed: "That stop signs be installed at the intersection of Pine Street and 5th Avenue (3-way) and Pine Street and 3rd Avenue (4-way) on a temporary basis until further data on its impact is obtained."

Mayor Berrigan has requested that this matter be brought back for reconsideration.

7.2 <u>Village of Chase Zoning Bylaw No. 683-2006, Amendment Bylaw No. 812-2015</u>

A public hearing was held in relation to this bylaw on November 3, 2015. The bylaw is now coming forward to Council to consider giving the bylaw third reading or defeating the bylaw at third reading.

7.3 Development Variance Permit Application No. 79-2015 – 110 455 VLA Road

This variance request is to reduce the setback from the interior side parcel line from 9.84 feet (3 meters) to 4 feet (1.2 meters). The R-1 Low Density residential zone permits a 1.5 meter interior side parcel line setback.

Notification has been sent to neighbouring property owners. Council is now being asked to consider approving the variance request. The Mayor is requested to ask if anyone in the gallery wishes to speak to this variance request prior to Council considering approving or denying the variance request.

7.4 Request for Additional Variance - #12–161 Shuswap Avenue

At its October 13, 2015 Regular meeting, Council heard from Mr. David Pearson of #12-161 Shuswap Avenue, requesting reconsideration of an additional variance for his carport. The existing approval allows for 10 feet between the outer edge of Mr. Pearson's carport and the neighbouring mobile home – the distance required by the Village's Mobile Home Park Bylaw is 20 feet. Mr. Pearson has requested Council consider the 10 feet be reduced to 6.90 feet. After hearing from Mr. Pearson, Council requested that the Fire Chief review the matter in advance of Council making a decision.

The Fire Chief has indicated he is not in favour of any additional reduction in the distance between the two mobile homes due to access for firefighters and associated safety relating to that access and egress in the event of a fire.

A resolution of Council is requested to either approve the additional variance or deny it.
