BACK TO SCHOOL

Tuesday, September 6th marks the beginning of the school year. Motorists are reminded that the speed limit in school zones is 30 km/h. Please be aware that children will be out.

Parents, you are also reminded to talk to your children about being safe while on the way to school. When walking they should walk on the left hand side of the roadway, facing traffic. Those who ride their bikes should be reminded to wear a bike helmet and to ride their bikes on the right hand side of the roadway—**not on the sidewalk**. Skateboards must not be ridden on sidewalks. Bikes should have lights or reflectors, front and rear. Children should be taught to obey all the rules of the road, including signaling and stopping at stop signs.
