Saturday, February 18, 2017 - Emerald City Fireworks Ltd. is conducting a fireworks training course. The practical portion of the training will occur at Memorial Park Wharf starting at 2 p.m. on Saturday February 18. Please be aware that fireworks discharge will produce loud noises; therefore please ensure your pets are secured between 2 and 3 p.m. that afternoon in that vicinity.

SNOW

- * Snow **plowing** on roads is prioritized by 1) emergency and school bus routes 2) main roadways 3) others
- * All property owners and tenants are reminded that you are required to remove snow and ice from **sidewalks** adjacent to your property by 11:00 a.m. No snow is to be moved onto public property except businesses in the downtown core
- * During a snow event, do not **park** vehicles or store anything on the boulevard <u>closer than 2 feet from pavement edge</u>. The Village will remove any obstacles to snow plowing equipment at your cost. The Bylaw Officer may also need to intervene.

Note: walkways in parks are not maintained in winter months

For further information refer to the *Streets and Parking Bylaw 732-2011* that regulates these matters.

Sewer Treatment Plant Upgrade Project

At the January 24, 2017 Council meeting, Council awarded a contract to Extreme Excavating to conduct our sewer treatment upgrade works.

It is anticipated that the contractor will be moving their equipment onto the site February 26, 2017, with works to begin in early March. As we have mentioned in past newsletters, the works will involve the desludging of Lagoon number 1, the removal of old aeration equipment in both Lagoons 1 and 2, and the installation of screens to filter material when it goes from the lagoons into the rapid infiltration basins.

Just a reminder to everyone that uses our sewer system – please ONLY put things down the drains and toilets that are appropriate for disposal through a sewer system – NO rags, blankets, toys, hygiene products, baby wipes, rope and the like....when we treat our infrastructure with respect, it will last longer and cost us less in taxes in the long run!

Dog Licenses – 2017 dog license renewals are available until March 1, 2017. After March 1, the full \$17 rate applies plus you risk also incurring an unlicensed dog ticket.

Business Licenses – All 2016 Business Licenses expired December 31, 2016. 2017 business licenses are available and right now there is a time-limited discount. For all the details please visit http://chasebc.ca/doing-business/business-licences/

Water Billing - As everyone is now aware, the Village's new water rate system is based on water consumption.
