

**VILLAGE OF CHASE**  
**Bylaw No. 820 - 2016**

A Bylaw to Establish Specified Fees and Charges in relation to Municipal Services

**(CONSOLIDATED FOR CONVENIENCE ONLY, INCLUDING BASE 820,  
AMENDMENTS 823, 829, 854, 872, 878, 884)**

---

**WHEREAS** the *Community Charter*, Chapter 26, S.B.C. 2003, and amendments thereto, empowers the Council to impose fees and charges in respect of all or part of a service of the municipality;

**AND WHEREAS** the Municipal Council of the Village of Chase deems it necessary to provide for the imposition of such fees and charges;

**NOW THEREFORE**, the Municipal Council of the Village of Chase in open meeting assembled, **ENACTS AS FOLLOWS**:

**1. TITLE**

This bylaw may be cited as "Village of Chase Fees and Charges Bylaw No. 820 - 2016".

**2. FEES**

Various fees and charges for the Village of Chase are established as set out in the following schedules, attached hereto and forming part of this Bylaw:

Schedule "A" – Administration and Office Fees;

Schedule "B" – Water, Sewer, Garbage Utilities Billing Cycle and Penalties;

Schedule "C" – Water and Sewer Utility Service Calls;

Schedule "D" – Water Service Rates;

Schedule "E" – Sewer Service Rates;

Schedule "F" – Solid Waste Service Rates;

Schedule "G" – Business License Rates;

Schedule "H" – Community Hall Rental Rates;

Schedule "J" – Development Fees; (Amending Bylaw No. 829)

Schedule "K" – Service Connection Fees; (Amending Bylaw No. 829)

Schedule "L" – Cemetery Fees. (Amending Bylaw No. 879)

**3. REPEAL**

“Village of Chase Fees and Charges Bylaw No. 808-2015” and any amendments thereto are hereby repealed in its entirety.

**4. SEVERANCE**

If any portion of this bylaw is declared ultra vires by a Court of competent jurisdiction or found to be illegal or unenforceable, that part or section shall be considered to be separate and severable from the bylaw to the intent that the remainder of the bylaw shall continue in full force and effect and shall be enforceable to the fullest extent permitted by law.

**UTILITIES BILLING CYCLE AND PENALTIES**

**Effective 1<sup>st</sup> January 2020** (Amending Bylaw No. 872)

- (a) The utility billing will be accomplished in 4 billing periods identified as follows:  
January 1 to March 31  
April 1 to June 30  
July 1 to September 30  
October 1 to December 31
- (b) Payments are applied to the oldest balance on each account first, then to current charges.
- (c) All water, sewer and solid waste charges left unpaid as of December 31 in each year shall be transferred to property taxes and shall bear interest at the rate established by the Provincial Government for arrears and delinquent taxes until paid.

  - b) Having considered all of the surrounding circumstances, it would be just and fair to so exempt the person.
10. Non-receipt of a utility billing will not exempt the customer from paying for the services received.

Events for fundraising purposes will require a Council decision in relaxing rental fees. Events with liquor may be considered differently than events without liquor. Damage deposits and incurred cleaning charges will still apply.

**Community Events**

- No fee for use of park/public space/electricity

**Mobile Vendor for Profit –**

**Multiple Approved License Areas allowed within the Village/1 Mobile Route:**

- Annual fee of \$250
- Annual means any period between January 1 and December 31 of a given year.
- If Village supplied electricity is used (pre-authorization must be made by the Village of Chase), fee will be \$5 per 24 hour period

**Mobile Vendor for Profit – 24 hour period – one approved license area:**

- \$50 which includes use of Village provided electricity if available and authorized by the Village for that specific vendor

**Mobile Vendor Associations for Events other than Community Events:**

- An annual fee of \$100 applicable to the License Area which covers all participating vendors for the duration of the event/season.
- An additional charge of \$5 per 24 hour period for each vendor requiring electricity provided it is available and approved for use by the Village

**Private Exclusive (per 24-hour period):**

- \$100 plus \$25 per hour (or portion thereof) after the first 2 hours, and includes all time used in physical preparation of the Public Space until it has been vacated for the purposes of the License
- Fee includes electricity if available and approved by the Village

**Use of Electricity (if available) on Village owned Land for circumstances other than those above:**

- \$5 per 24 hour period

All fees are in addition to required Business License Fees (if applicable).

Fees are payable upon the issuance of the license and may be modified or waived in special circumstances. Unpaid fees will result in the withholding of the License the subsequent year.

**DEVELOPMENT FEES** (Amending Bylaw No. 854)

1. Every application for amendment to the Official Community Plan shall be charged a fee of Eight Hundred Dollars (\$800.00).
2. Every application for a Zoning Bylaw amendment shall be charged a fee of Eight Hundred Dollars (\$800.00).
3. Every simultaneous application for an Official Community Plan Bylaw amendment and Zoning Bylaw amendment shall be charged a combined fee of Twelve Hundred Dollars (\$1200.00).
4.
  - a) Every application for a minor Development Permit less than one million (\$1,000,000) in construction costs shall be charged a fee of Five Hundred Dollars (\$500.00).
  - b) Every application for a major Development Permit more than one million (\$1,000,000) in construction costs shall be charged a fee of Twelve Hundred Dollars (\$1200.00) per one million (\$1,000,000) in construction cost to a maximum of Forty Eight Hundred Dollars (\$4800.00).
5. Every application for a Development Variance Permit shall be charged a fee of Five Hundred Dollars (\$500.00).
6. Every application for a Temporary Use Permit shall be charged a fee of Four Hundred Dollars (\$400.00).
7. Every application for a subdivision shall be charged a fee of Five Hundred Dollars (\$500.00), plus One Hundred Dollars (\$100.00) per lot created, plus a 2% administration fee. *Note: the administration fee will be based on a certified estimate of construction value for off-site and on-site municipal services, payable at Final Approval.*

There shall be no refunds except:

- a) when an application which requires statutory advertising is refused or withdrawn prior to advertising the required notice in a newspaper; or,
- b) when a ‘Zoning Amendment Application for Short-Term Rental’ form is received, accepted by Council, and processed through to completion of a Public Hearing.

The amount of refund in the above situations shall be Four Hundred Dollars (\$400.00).

  - a) New Controlled Substance License application shall be charged a fee of One Thousand Dollars (\$1,000)
  - b) An amendment to a Controlled Substance License application shall be charged a fee of Three Hundred Dollars (\$300)
  - c) Food Primary License application shall be charged a fee of Three Hundred Dollars (\$300)
  - d) Liquor/Food Primary License, Temporary Amendment, shall be charged a fee of One Hundred Dollars (\$100)
