

THE CORPORATION OF THE VILLAGE OF CHASE.

By-Law No. 19.

A By-law of the Corporation of the Village of Chase to regulate the hours of closing of shops within the Village.

WHEREAS It is deemed to be in the public interest to exempt all classes of shops within the boundaries of the Corporation of the Village of Chase( hereinafter reffered to as the "Village") from the provisions of Section 858 and 859 of the "Municipal Act":

NOW THEREFORE the Council of the Village of Chase, in open meeting assembled, enact as follows:

1. Pursuant to Section 857 (2) of the "Municipal Act" all classes of shops within the boundaries of the Village of Chase are hereby defined as follows:
  - BARBER. Any shop specializing in the business of a barber.
  - BUTCHER SHOP. Any shop specializing in the sale of fresh and/or frozen meat products, fish, vegetables and dairy products.
  - BUILDING SUPPLY SHOP. Any shop specializing in the sale of building materials and related products.
  - CLOTHING STORE. Any shop specializing in the sale of clothing or clothing material.
  - DEPARTMENT STORE. Any shop specializing in the sale of any groceries, dry goods, hardware or building material.
  - DRESS SHOP. Any shop specializing in the sale of ladies and girls clothes.
  - APPLIANCE SHOP. Any shop specializing in the sale of home appliances such as furniture, electric and other appliances.
  - Grocery Store. Any shop offering for sale such items as fresh and frozen meats, fish, vegetables, canned goods, confections and other food items.
  - HAIRDRESSER. Any shop specializing in hair dressing.
  - HARDWARE STORE. Any shop offering for sale such articles as plumbing supplies, paint, electrical supplies, building supplies, tools and other related products.
  - DRUG STORE. Any shop specializing in the sale of medical drugs, either by direct sale or by means of a medical prescription and having a licensed pharmacist employed.
  - NOVELTY SHOP. Any shop offering for sale such items as pottery, chinaware, homemade crafts, nick-nacks, toys, games and other items of a similar nature.
  - SPORTS SHOP. Any shop which offers for sale such items as hunting equipment and sporting equipment of all kinds.
  - SHOE SHOP. Any shop which specializes in the sale of shoes of all kinds and related footwear.
  - Variety Shop. Any shop which offers for sale such items as games, novelties, toys, clothing and other miscellaneous goods.

- 2. Pursuant to Section 861 (1) of the "Municipal Act" all classes of shops as defined in Section 1 of this By-law are hereby exempt from Sections 858 and 859 of the said "Act". *JS*
- 3. This By-law shall take effect upon registration thereof in the office of the Inspector of Municipalities.
- 4. This By-law may be cited as "Village of Chase Shop Closing Hours By-law No. 19, 1970".
