## VILLAGE OF CHASE

## BY-LAW NO.65

A By-law to authorize the borrowing of money for a purpose of constructing a Public Works building on Lot 6, Plan 1467, D.L. 517.

whereas, pursuant to the provisions of section 260 of the Municipal Act, the Council may contract a debt for any purpose of a capital nature such debt not to exceed at any time a total amount equal to twenty dollars (\$20.00) multiplied by the population figure of the municipality or Five Hundred Thousand Dollars (\$500,000.00) whichever is the lesser and may by by-law, without the assent of the owner-electors, contract the debt by borrowing and make provision for the repayment of the debt and interest thereon.

AND WHEREAS, the amount of the existing obligations of the municipality is \$100,000.00 of which \$100,000.00 is existing outstanding debenture debt and none of the principal or interest of the debenture debt of the municipality is in arrears.

AND WHEREAS, the Council deems it necessary to borrow the sum of \$24,000.00 for the purpose of constructing a Public Works building.

AND WHEREAS the approval of the Insepctor of Municipalities has been obtained.

NOW THEREFORE, the Council of the Village of Chase in open meeting assembled ENACT AS FOLLOWS:

to berrow upon the credit of the Village of Chase from the Canadian Imperial Bank of Commerce, the sum of Twenty Four Thousand Dollars (\$24,000.00) at such times as the same may be required for the purpose hereinbefore recited and to pay interest thereon at a rate of Eight (8) per centum per annum.

There shall be raised and levied during the currency of the obligation hereby created by a rate sufficient therefore over and above all other rates upon all land and improvements subject to taxation for general municipal purposes in the municipality for the repayment of the debt and the payment of the interest thereon in the respective years the amount as follows:
