

VILLAGE OF CHASE

BY-LAW NO. 94

A By-law to authorize a submission to the owners of land within the Village of Chase on the question of participating in the function of a Public Library System.

WHEREAS the Village of Chase has been asked to participate in the function of the establishment of an operation of an intergrated public library system under the Thompson-Nicola Regional District for member municipalities of the City of Kamloops, Town of Merritt, Villages of Ashcroft, Cache Creek, Clinton, Chase, Logan Lake, Lytton, and Electoral Areas "A", "B", "C", "D", "E", "I", "J", "L", "M", and "N".

NOW THEREFORE the Village of Chase in open meeting assembled ENACT AS FOLLOWS:

1. This by-law may be cited as, "Village of Chase Intergrated Public Library System Referendum By-law No. 94, 1973".

2. A poll will be taken of the owners of land within the Village of Chase, qualified to vote in accordance with the provisions of the "Municipal Act" to determine whether or not the owners of land wish to participate in the function of the establishment of an operation of an intergrated library system for the member municipalities of the City of Kamloops, Town of Merritt, Villages of Ashcroft, Cache Creek, Clinton, Chase, Logan Lake, Lytton, and Electoral Areas "A", "B", "C", "D", "E", "I", "J", "L", "M", and "N".

3. The Board shall requisition a sum not exceeding the product of $1\frac{1}{2}$ mills, in any one year, on all lands and improvements, on the basis of assessment as fixed for taxation for school purposes, including property that is taxable for school purposes only by special act, within said areas, for the purpose of operating the said library function.

4. The poll shall be taken on the 17th day of November, 1973 between the hours of 8:00 o'clock in the forenoon and 8:00 o'clock in the afternoon.

5. The question on the ballot-paper shall read: "Are you in favor of the Village of Chase participating in the establishment of a function by the Thompson-Nicola Regional District to provide for the operation of an intergrated Public Library System pursuant to the provision of Section 56A of the "Public Libraries Act".

READ A THIRD TIME THIS 30 DAY OF October , 1973
