ZONING AMENDMENT BY-LAW NO. 121, 1975 JUL - 7 1975

A By-law of the Village of Chase to change the zoning classification from I.1 Industrial to R.1 Residential that part known as Lots 11 to 18, Block X, Plan 794; Lots 11 to 20, Block S, Plan 794; Lots 1 to 10, and 12 to 16, Parcel Z, Plan 1989; Lots 5 to 14, Block E, Plan 794; Lots 1 to 8 and Lot Z and Lots 11 to 24, Block T, Plan 794; Lots 1 to 16, Block U, Plan 794; Lots 1 to 10, Block Q, Plan 794; and Lots 1 to 12, Block R, Plan 794; all in District Lot 517.

Also to change the zoning classification from C.1 General Commercial to R.1 Residential that part known as Lots 6 to 10, Block X, Plan 794, District Lot 517.

The Council of the Village of Chase, in open meeting assembled, ENACTS AS FOLLOWS:-

- 1. The zoning classification of that part known as Lots 11 to 18, Block X, Plan 794; Lots 11 to 20, Block S, Plan 794; Lots 1 to 10, and 12 to 16, Parcel Z, Plan 1989; Lots 5 to 14, Block E, Plan 794; Lots 1 to 8 and Lot Z, and Lots 11 to 24, Block T, Plan 794; Lots 1 to 16, Block U, Plan 794; Lots 1 to 10, Block Q, Plan 794; and Lots 1 to 12, Block R, Plan 794; all in District Lot 517, is hereby changed from I.1 Industrial to R.1 Residential.
- The zoning classification of that part known as Lots 6 to 10, Block X, Plan 794, District Lot 517, is hereby changed from C.1 General Commercial to R.1 Residential.
- 3. This By-law may be cited as "Village of Chase Zoning Amendment By-law No. 121, 1975".
