WHEREAS the following described portions of the road in the Village of Chase in the Province of British Columbia as shown outlined in red on the plan attached hereto and forming part of this By-law are not required by the Village of Chase;

AND WHEREAS the owners of the properties adjoining the said portion of the road to be stopped-up have consented to the stopping-up and closing and no residents or owners of property will be adversely affected thereby;

AND WHEREAS the Council may, pursuant to Section 513, of the "Municipal Act" R.S.B.C. Chapter 255 and all amendments thereto, stop-up and close to traffic the portion of highway which is proposed to be abandoned.

NOW THEREFORE the Municipal Council of the Village of Chase in Open Meeting assembled, enacts as follows:

1. That that part of the road in The Village of Chase described as:

ALL AND SINGULAR that portion of road as shown in Lot 2, Plan 28320, shown outlined in red on the plan attached hereto and forming part of this By-law;

be and the same is hereby stopped-up and closed for traffic and added to and forming a part of Lot 2, Plan 28320.

2. This By-law may be cited for all purposes as "Road Closure By-law No. 187, 1978."

HIGHWAY ABANDONMENT

WHEREAS the Council of the Village of Chase has by By-law No. 187 cited as "Road Closure By-law No. 187, 1978" a copy of which is hereto attached, stopped up and closed to traffic that portion of highway as shown outlined in red colour on the plan attached to and made part of said By-law No. 187:

AND WHEREAS the Council has requested the Minister of Municipal Affairs to abandon the aforesaid portion of highway pursuant to Section 508 of the Municipal Act and to vest title to the lands comprising same in the name of the contiguous owners and has demonstrated to the satisfaction of the Minister that special circumstances exist which warrant the making of this Order:

AND WHEREAS the consent of owners of contiguous properties has been obtained and the question of access is not in issue:

I HEREBY order that the portion of highway aforesaid be abandoned and that title to the lands comprising same be vested in fee simple in the name of Robert John Laughy and Adolf Lehmann without further instrument of transfer subject nevertheless to the reservations, limitations, provisos and conditions expressed in the original grant thereof from the Crown and subject to the provisions of Section 47 of the Land Act and subject to consolidation with Lots 1 and 2, District Lot 517 Kamloops Division Yale District Plan 28320.




