A By-law of the Village of Chase to amend Village of Chase Sanitary Sewerage System Loan Authorization By-law No. 240, 1981.

WHEREAS the Council of the Village of Chase with the approval of the Inspector of Municipalities, find it necessary to amend the Village of Chase Loan Authorization By-law No. 217, which was amended by By-law No. 240, which provides for borrowing upon the credit of the Village of Chase.

AND WHEREAS it has been found that subsequent of the Enactment of By-law No. 240 that the Total Cost of constructing the works will be \$3,100,000.

AND WHEREAS it has been necessary and expedient to amend By-law No. 240, to increase the amount to be borrowed upon the credit of the Village of Chase from \$2,510,000.00 to \$3,100,000.00.

NOW THEREFORE the Council of the Village of Chase assembled enacts as follows:

1. That Loan Authorization By-law No. 217 of the Village of Chase as amended by By-law No. 240 is hereby amended as follows:
 1. By deleting the figure \$2,510,000.00 from the second WHEREAS Clause, and substituting therefore the figure \$3,100,000.00.
 2. By deleting \$2,510,000.00 in Clause 1, Subsection 1, and substituting therefore the figure \$3,100,000.00.
2. This By-law may be cited as "Village of Chase Sanitary Sewerage System Loan Authorization Amendment By-law No. 254, 1982."
