BY-LAW NO. 257

A By-law of the Village of Chase Amending the Capital Expenditures for the Period 1982 to 1986 inclusive.

The Council of the Village of Chase, in open meeting assembled, enacts as follows:



RECONSIDERED AND ADOPTED this 27<sup>th</sup> day of JANUARY, 1983.


