

VILLAGE OF CHASE

BY-LAW NO. 296

Being a By-law for the levying of rates for Municipal, Hospital District and Regional District purposes for the year 1985.

The Council of the Village of Chase, in open meeting assembled, ENACTS AS FOLLOWS:

1. The following rates are hereby imposed and levied for the year 1985.

(a) For all lawful general purposes of the municipality on the value of land and improvements taxable for general municipal purposes, rates appearing in column "A" of the Schedule attached hereto and forming a part hereof.

(c) For hospital purposes on the value of land and improvements taxable for regional hospital district purposes, rates appearing in column "C" of the Schedule attached hereto and forming a part hereof.

(e) For purposes of the Thompson-Nicola Regional District on the value of land and improvements taxable for regional hospital district purposes, rates appearing in column "E" of the Schedule attached hereto and forming a part hereof.

2. The minimum amount of taxation upon a parcel of real property shall be One Dollar (\$1.00).

3. This By-law may be cited as "Tax Rates By-law No. 296, 1985.
