VILLAGE OF CHASE

BY-LAW NO. 318

A By-law authorizing the expenditure of monies in the Capital Works, Machinery and Equipment Reserve Fund.

WHEREAS there is an unappropriated balance in the Capital Works, Machinery and Equipment Reserve Fund as at December 16, 1985, which amount has been calculated as follows:

Balance in Reserve Fund at December 31, 1984 - \$ nil
Addition to fund including interest earnings
for current year to date - 80,827.00
Balance in Reserve Fund as at December 16, 1985- 80,827.00

AND WHEREAS the approval of the Minister of Municipal Affairs has been obtained:

NOW THEREFORE the Council of the Village of Chase, in open meeting assembled, enacts as follows:

1. The sum of \$ 80,827.00 is hereby appropriated from the Reserve Fund to be expended on the Water Pumphouse Upgrading Project.
2. The expenditure to be carried out by the monies hereby appropriated shall be more particularly specified and authorized by resolution of the Council.
3. Should any of the above amount remain unexpended after the expenditures hereby authorized have been made, any unexpended balance shall be returned to the credit of the said Reserve Fund.
4. This by-law may be cited as the "Reserve Fund Expenditure By-law No. 318, 1985".


