

VILLAGE OF CHASE

BY-LAW NO. 339

WHEREAS it is provided by Section 400 of the Municipal Act, being Chapter 290 of R.S.B.C. 1979 and amendments thereto, that the Council may, by by-law, exempt from taxation any lands and improvements therein specified;

AND WHEREAS the Council of the Village of Chase deems it necessary and expedient to exempt from taxation the whole of the taxable assessed value of the land and improvements owned by the Chase and District Curling Club, Old Age Pensioners Branch #53, Evangelical Free Church of America, United Church of Canada, Synod of Diocese of Kootenay, Jehovah's Witness Congregation, Roman Catholic Bishop of Kamloops located on the hereinafter described property.

NOW THEREFORE, the Municipal Council of the Village of Chase, in open meeting assembled, hereby enacts as follows:

- 1. The Village of Chase hereby authorizes that the land and improvements of the:
  - Chase and District Curling Club: Lot B, District Lot 517, Plan 19733, K.D.Y.D.
  - Old Age Pensioners Branch #53: Parcel Y of Block A, District Lot 517, Plan 514, K.D.Y.D.
  - Evangelical Free Church of America: Lot 1, District Lot 517, Plan 19564, K.D.Y.D.
  - United Church of Canada: Lot A, District Lot 517, Plan 8227, K.D.Y.D.
  - Synod of Diocese of Kootenay: Lots 4 & 5, Block N, District Lot 517, Plan 514, K.D.Y.D.
  - Jehovah's Witness Congregation: Lots 17-20, Block P, District Lot 517, Plan 514, K.D.Y.D.
  - Roman Catholic Bishop of Kamloops: Part of Lot 6, District Lot 517, Plan 8757, K.D.Y.D.
 be exempted from taxation for the year 1987 only.

- 2. This by-law may be cited as the "1987 Tax Exemption by-Law No. 339."
