BY-LAW NO. 359

A BY-LAW TO AMEND THE VILLAGE OF CHASE OFFICIAL COMMUNITY PLAN BYLAW NO. 263, 1983.

WHEREAS the Village of Chase has an existing Official Community Plan adopted as Village of Chase Community Plan No. 263, 1983;

AND WHEREAS the Village of Chase deems it desirable, in order to ensure that the Official Community Plan in place is appropriate for current conditions, that the Official Community Plan be amended;

AND WHEREAS a Public Hearing will be held in accordance with the provisions of Section 956(1) of the Municipal Act;

NOW THEREFORE the Council of the Village of Chase, in open meeting assembled, ENACTS AS FOLLOWS:

- 1. This bylaw may be cited for all purposes as the "Village of Chase Official Community Plan Amendment Bylaw No. 359, 1987".
- 2. Lots 3 - 11 inclusive, Block W, Plan 794, District Lot 517, KDYD, are hereby changed from General Commercial to Low Density Residential; and
 Lots 21, 22 and 23, Block T, Plan 794, District Lot 517, KDYD, are hereby changed from Low Density Residential to Mobile Home Residential;
 both as outlined in red on the attached Schedule "A"
- 3. The map attached hereto as Schedule "A" is incorporated in and forms part of this bylaw.

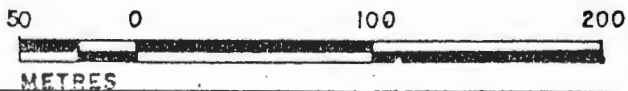
