VILLAGE OF CHASE

BY-LAW NO. 454

WHEREAS it is provided by Section 400 of the Municipal Act, being Chapter 290 of R.S.B.C. 1979, and amendments thereto, that the Council may, by By-Law, exempt from taxation any lands and improvements herein specified;

AND WHEREAS the Council of the Village of Chase deems it necessary and expedient to exempt from taxation, the whole of the taxable assessed value of the land, and improvements owned by the Chase and District Church of America, United Church of Canada, Synod of the Diocese of Kootenay, Jehovah's Witness Congregation, Chase and District Museum and Archive Society, and Roman Catholic Bishop of Kamloops, located on the hereinafter described property.

The Municipal Council of the Village of Chase, in open meeting assembled, ENACTS AS FOLLOWS:

- 1. The Village of Chase hereby authorizes for the 1993 Tax year exemption for the following land and improvements:
 - 1. Chase and District Curling Club: Parcel Z, District Lot 517, Plan KC5244, K.D.Y.D.;
 - 2. Old Age Pensioners Branch #53: Parcel Y of Block A, District Lot 517, Plan 514, K.D.Y.D.;
 - 3. Evangelical Free Church of America: Lot A, District Lot 517, Plan 41858, K.D.Y.D.;
 - 4. United Church of Canada: Lot A, District Lot 517, Plan 8227, K.D.Y.D.;
 - 5. Synod of Diocese of Kootenay: Lots 4 and 5, Block N, District Lot 517, Plan 514, K.D.Y.D.;
 - 6. Jehovah's Witness Congregation: Lots 17-20, Block P, District Lot 517, Plan 514, K.D.Y.D.;
 - 7. Roman Catholic Bishop of Kamloops, Lot B, Plan 36502, District Lot 517, K.D.Y.D. save and except that portion required for dwelling allowed by the Development Variance Permit #9;
 - 8. Chase and District Museum and Archive Society, Part of Lot 6, District Lot 517, K.D.Y.D.;
 - 9. Whitfield Park, part of DL 517, shown on Plan B 256 except Plan B 375, and A634 as shown in Parcel A lease Plan 37756 PID 004-031-610

Be exempt from taxation for the year 1993 only.

2. This By-law may be cited as 1993 Tax Exemption Bylaw No.454.
