VILLAGE OF CHASE

BY-LAW NO. 491

WHEREAS it is provided by Section 400 of the Municipal Act, being Chapter 290 of R.S.B.C. 1979, and amendments thereto, that the Council may, by By-Law, exempt from taxation any lands and improvements herein specified;

AND WHEREAS the Council of the Village of Chase deems it necessary and expedient to exempt from taxation, the whole of the taxable assessed value of the land, and improvements owned by the Chase and District Church of America, United Church of Canada, Synod of the Diocese of Kootenay, Jehovah's Witness Congregation, Chase and District Museum and Archive Society, Roman Catholic Bishop of Kamloops, and Chase and District Health Society located on the hereinafter described property.

The Municipal Council of the Village of Chase, in open meeting assembled, ENACTS AS FOLLOWS:
