Section 8 - Agendas is amended by deleting section a) 13.


2. This Bylaw may be cited as " Village of Chase Council Procedure Amendment Bylaw No. 622-2001".

**VILLAGE OF CHASE
BYLAW NO. 621-2001**

Being a Bylaw for the levying of rates for Municipal,
Hospital District and Regional District purposes for the year 2001

NOW THEREFORE the Council of the Village of Chase, in open meeting assembled, enacts as follows:

1. This Bylaw may be cited as "Tax Rates Bylaw No. 621-2001".
2. The following rates are hereby imposed and levied for the year 2001.
 - a) For general purposes of the municipality on the value of land and improvements taxable for general municipal purposes, rates appearing in Column "A" of Schedule "A" attached to and forming part of this Bylaw.
 - b) For hospital purposes on the value of land and improvements taxable for hospital purposes, rates appearing in Column "C" of Schedule "A" attached to and forming part of this Bylaw.
 - c) For regional district purposes on the value of land and improvements taxable for hospital purposes, rates appearing in Column "E" of Schedule "A" attached to and forming part of this Bylaw.
3. The minimum amount of taxation upon a parcel of real property shall be One Dollar (\$1.00).
