BYLAW NO. 632, 2002

A BYLAW RELATING TO ADMINISTRATIVE FEES FOR THE VILLAGE OF CHASE

WHEREAS the Local Government Act, Chapter 323, R.S.B.C. 1996, and amendments thereto, empowers the Council to impose fees and charges in respect of all or part of a service or regulatory scheme of the municipality;

AND WHEREAS the Municipal Council of the Village of Chase deems it necessary to provide for the imposition of such fees and charges;

NOW THEREFORE, the Municipal Council of the Village of Chase in open meeting assembled, enacts as follows:

1. Title

This bylaw may be cited as "Village of Chase Administrative Fees Bylaw No. 632, 2002."

2. Fees

The following fees are hereby fixed:
