 - 5.(g) A person shall not park anytime between 7:00 p.m. and 7:00 a.m. any vehicle with a gross vehicle weight of 7000 kilograms or greater on any highway or property in a residential or commercial area other than those areas zoned as Highway Commercial or Industrial in the Village of Chase Zoning Bylaw. This section shall not apply to Parcel B, Plan A634, District Lot 517, Kamloops Division of Yale Land District.
- 2. This bylaw may be cited as "Village of Chase Highway, Traffic and Parking Regulation Bylaw No. 482 Amendment Bylaw No. 644, 2003."
