BYLAW NO. 679 - 2006

A BYLAW TO AMEND VILLAGE OF CHASE BUSINESS LICENSE BYLAW NO. 616 - 2001.

WHEREAS the Council of the Village of Chase has adopted the Village of Chase Business License Bylaw No. 616 - 2001;

AND WHEREAS the Council of the Village of Chase deems it necessary to amend Bylaw No. 616;

NOW THEREFORE, the Council of the Village of Chase in open meeting assembled, enacts as follows:

1. That Business License Bylaw No. 616-2001 is hereby amended as follows:

That section 37 "Prorating of Fees" be repealed in its entirety and replaced with the following:

37 Prorating of Fees

Business License fees set forth herein for any Business which becomes liable to be licensed after July 31st shall be reduced by 50% of the full Annual Fee as set forth in Schedule "A" of this bylaw.

2.

- a) That Schedule "A" to Bylaw No. 616 2001 "Fees Payable for the Business Licensing Period" be repealed in its entirety and replaced with Schedule "A" "Fees Payable for the Business Licensing Period" attached to and forming part of this bylaw.
- b) That Schedule "C" to Bylaw No. 616 2001 "Business License Application" be repealed in its entirety and replaced with Schedule "C" "Business License Application" attached to and forming part of this bylaw.

3. CITATION

That this Bylaw shall be cited as "Village of Chase Business License Bylaw No. 616 – 2001 Amendment Bylaw No. 679 – 2006."
