## BYLAW NO. 688-2006

## Being a Bylaw to provide for permissive tax exemptions for the year 2007

**WHEREAS**, it is provided in the Local Government Act, that the Council may, by Bylaw, exempt from taxation certain lands and improvements:

The Municipal Council of the Village of Chase, in open meeting assembled, **ENACTS AS FOLLOWS**:
