## BYLAW NO. 713-2008

## Being a Bylaw to provide for permissive tax exemptions for the year 2009

WHEREAS, under the authority of Section 224 of the Community Charter, SBC 2003 Chapter 26, the Council for the Village of Chase may by by-law exempt from taxation, land and improvements,

**NOW THEREFORE**, the Council of the Village of Chase, in the Province of British Columbia, in open meeting assembled, hereby enacts as follows:
