A BYLAW TO AMEND THE VILLAGE OF CHASE ZONING BYLAW NO. 683 - 2006

WHEREAS the Council of the Village of Chase has adopted the Village of Chase Zoning Bylaw No. 683 - 2006;

AND WHEREAS the Council of the Village of Chase deems it necessary to amend Bylaw No. 683;

NOW THEREFORE, the Council of the Village of Chase in open meeting assembled, enacts as follows:

- 1. That this bylaw shall apply to and only to those lands legally described as Lot A, District Lot 517, Kamloops Division Yale District, Plan KAP88844 and as identified by bold outline on Schedule "A" attached hereto and forming a part of this bylaw.
- 2. That the Village of Chase Zoning Bylaw No. 683 is hereby amended for the above-noted lands as follows:
 - (a) The required off-street parking requirement is reduced from 1 parking space per 50 square metres of gross floor area to 1 parking space per 100 square metres of gross floor area.
 - (b) The required number of loading spaces is reduced for a floor area between 465 square metres and 2300 square metres from 2 loading spaces to 1 loading space.
- 3. THAT this bylaw may be cited as "Village of Chase Zoning Amendment Bylaw No. 716 2009."


