## VILLAGE OF CHASE BYLAW NO. 720-2009

Being a Bylaw for the Levying of Taxation Rates for Municipal, Hospital District and Regional District purposes for the year 2009

NOW THEREFORE the Council of the Village of Chase, in open meeting assembled, enacts as follows:

1. This Bylaw may be cited as "Village of Chase Tax Rates Bylaw No. 720-2009".
2. The following rates are hereby imposed and levied for the year 2009.
a) For general purposes of the municipality on the value of land and improvements taxable for general municipal purposes, the rates appearing in Column A of Schedule "A" attached to and forming part of this Bylaw shall apply.
b) For hospital purposes on the value of land and improvements taxable for hospital purposes, rates appearing in Column B of Schedule "A" attached to and forming part of this Bylaw shall apply.
c) For regional district purposes on the value of land and improvements taxable for hospital purposes, rates appearing in Column C of Schedule "A" attached to and forming part of this Bylaw shall apply.
3. The minimum amount of taxation upon a parcel of real property shall be One Dollar (\$1.00).
