The Village of Chase Zoning Bylaw No. 683-2006, is hereby amended by changing the permitted land use on Lot A, Plan 31230, DL 517, KDYD and that portion of closed road in Lots 5 and 6, Block E, Plan 794 as shown on Plan 35895, DL 517, KDYD from "C-1 General Commercial" to "R-1 Low Density Residential" as shown on Schedule "A" attached to and forming part of this Bylaw.


