5. PUBLIC INPUT ON CURRENT AGENDA ITEMS

Beverley Iglesias, of 621 3rd Avenue, regarding item 8.6, encouraged Council to resist entertaining continual requests from non-profit groups to reduce or waive the Community Hall rental rates. She stated that the rates are decent and fair for all users.

6. DELEGATIONS

Blaine Wiggins, M.A., Manager, First Responder Program & Indigenous Health
Strategy and Transformation, BC Emergency Health Services (BCEHS) regarding
First Responder Program

Mr. Wiggins referred to the recent auditor general report which recommends a more coordinated effort between fire departments and BCEHS, that improved coordination with fire departments is needed to support consistent application of medical standards, information sharing and improvements to patient care. He added that:

- The First Responder (FR) program allows for a fire department to respond to medical calls at its discretion
- The FR program agreement is flexible, that is, if entered into it can be terminated at any time
- Entering into an agreement is not downloading but a partnership
- Some equipment and training would be provided where possible

Mr. Wiggins answered questions of Council including:

- Approximately 400 agencies across BC have entered into a First Responder partnership agreement, and between 15 and 20% of these are societies providing that service
- Rural areas are more likely served by societies
- The agreement can ensure that only higher level calls are dispatched to the Fire Department – call-outs to the Fire Department can be 'scaled' to higher level calls only if that is the wish of the municipality
- There is no requirement to pay members for FR callouts, that is up to the individual agency to determine
- Liability is covered by BCEHS when the members are at the event to and from transportation is not covered by BCEHS
- If a call can be serviced, great, and if not, that is what it is

Other comments of Council members:

- Comes down to a cost implication to the municipality because there is no funding for vehicles – there would be some costs incurred by the municipality
- Calls would be within the Village's boundaries unless otherwise specified in the agreement

Mayor Crowe thanked Mr. Wiggins for his time and information.

6.2 Connie Seaward regarding Turtle Valley Biosolids

Ms. Seaward explained the situation where the City of Kamloops will be exporting 35,000 dry tonnes of Class B biosolids to be applied to a ranch in Turtle Valley and she states this dumping activity will negatively impact their community and the road network in the area. She asked for support from the Village of Chase and raised concerns that there are no safeguard measures in place if something goes wrong, the material will be very close to Chum Lake which is a ducks unlimited sanctioned area with 16 water licenses, and Chum Lake feeds into the Little Shuswap Lake. A member of the Little Shuswap Lake Indian Band spoke up and stated that the biosolids were initially earmarked to be applied to land in the community of Little Shuswap Lake Indian Band and the band members vehemently opposed this initiative, which is why the biosolids are being transported elsewhere. She offered to work with the Turtle Valley residents in their pursuit to stop the application of the biosolids in Turtle Valley.

10. OPPORTUNITY FOR PUBLIC TO SPEAK ON MUNICIPAL MATTERS

Lou Belanger, of 1200 Bay Drive, expressed frustration from his experience with a neighbour's smoky open fire, alleging that the fire size was in excess of the 'backyard fire' regulations, and that the fire contained improper burning materials such as tires. He indicated that the Fire Chief attended the scene twice, as well as another on-call firefighter. He also indicated that it appeared there was no water source for the fire.

Beverley Iglesias, of 621 3rd Avenue, shared some of her experiences as a pedestrian in Chase, referred to a proposal in the Lower Mainland for a reduction in vehicle speeds to 30 km/h, and recommended that Council consider changing the speed limit in Chase to 30 km/h.
