ISSUE/PURPOSE

To seek Council approval to submit a grant application to the Community Emergency Preparedness Fund under the 2022 Extreme Heat Risk Mapping, Assessment, and Planning.

OPTIONS

1. Endorse the submission of the grant application
2. Do not endorse the submission of the grant application

HISTORY/BACKGROUND

Community Emergency Preparedness Fund is a suite of funding programs intended to enhance the resiliency of local governments and their residents in responding to emergencies. Funding is provided by the Province of BC and is administered by the Union of BC Municipalities (UBCM). The Province of BC has recognized the threat extreme heat poses for communities across BC. The intent of this funding stream is to support eligible applicants to ensure they have accurate knowledge of the risks associated with extreme heat and how these risks will change over time, and to develop effective response plans, and strategies to prepare, mitigate and adapt to those risks.

DISCUSSION

The Village has actively been updating Emergency Operations processes, training, supplies and equipment as funding becomes available.

The Extreme Heat Risk Mapping, Assessment and Planning would potentially enable the Village to expand the emergency works to include identification of populations disproportionately at risk. Risk assessments, community engagements, and other available data will be utilized to complete an extreme heat plan. Developing an extreme heat response plan offers an opportunity for communities to identify vulnerable populations and develop effective response plans and strategies to prepare, mitigate, and adapt to those risks identified.

FINANCIAL IMPLICATIONS


The Community Emergency Preparedness Extreme Heat Risk Mapping, Assessment and Planning funding stream is 100% of the cost of eligible activities to a maximum of \$30,000. The application deadline is June 24, 2022.



Shuswap Rowing & Paddling Club respectfully invites you to experience and participate in the Shuswap Dragon Boat Cancer Survivor Carnation Ceremony at 11 am on Saturday June 18th, 2022, in Marine Peace Park, Salmon Arm.

Our club's vision for a Carnation Ceremony was developed due to the very recent and unexpected cancellation of the 2022 Shuswap Dragon Boat Festival. We still want to honour breast cancer survivor teams and are committed to proceed with this aspect of the Shuswap Dragon Boat Festival, even if we will not have a full day of competitive racing as well.

The festival is normally held in June and teams from across the province were excited about this year's event. Regrettably, as most teams are still trying to decide how to return to normal following COVID-19, there were not enough teams registered to hold a successful race event.

The Dragon Boat Cancer Survivor Carnation Ceremony is a tradition in dragon boat festival and race culture worldwide. The Ceremony celebrates the opportunity offered to survivors and supporters to recognize those who have been diagnosed, are in remission, or who live day to day with cancer and those who have passed away.

The traditional Carnation Ceremony dates back to 1996 in Vancouver, BC. A dragon boat paddler picked bright pink roses from her garden and gave them to fellow paddlers who tossed them into the water after a race as a way to honour a cancer survivor and team member who could not participate. Soon thereafter, pink carnations and an emotional and empowering ceremony evolved into this inspiring tradition within the dragon boat community as a symbol of love and respect for all these women and men.

For our 2022 event, Dragon Boat cancer survivors from Fort Langley, Kamloops, Revelstoke, Vernon and Shuswap have been invited to participate. Dragon boats carrying breast cancer survivors — each holding a flower — will be gathered together so families, friends and other spectators can also join in from the wharf.

We invite you to join us at the end of the wharf to experience this unique event. The morning itinerary has been included as an attachment with this letter and provides an opportunity for you or a delegate to speak on behalf of your municipal/regional district/First Nations organization.

We would be pleased if you would consider participating in this event as our honoured guest and ask for a reply at your earliest convenience.

RE: Requests for Lakeside Summer Music Series

The Chase & District Festival Society (CDFS) is seeking permission from the Village of Chase to allow for temporary parking and road closures on July 1st from approximately 2pm to 4pm for the Canada Day Parade. The parade will follow the standard route from Art Holding Memorial Arena to the parking lot of PharmaChoice Food & Drug. As in the previous years, the parking closures along Shuswap Ave will occur between Wilson St and Chase St, and will run from 2pm to 4pm. The road closures will start just after 3pm and go until 4pm, with the closures happening in limited sections as the parade approaches, and will reopen when the parade passes. The Chase Citizens on Patrol (COP) will be assisting with the closures, and the RCMP have been informed of the route and times. If the Chase Fire Department can provide a member to direct traffic at the intersection of Shuswap Ave and Chase St following the parade, that would be helpful, as this has historically been an area of congestion. We would also appreciate the use of barricades along Shuswap Ave at key intersections, which COP will coordinate with Public Works.

The ceremony portion of Canada Day will be at 6pm on July 1st at Memorial Park and we would like to invite all members of council to attend.

In addition, we are seeking formal permission to use Wilson Park, Centennial Park, and Memorial Park on July 1st, as well as access to the power sources at each of these parks during the day. We are also requesting use of the bathrooms in the basement of the Community Hall on July 1st between 12pm and 3pm as there will be activities at nearby Wilson Park for the opening of the renewed horseshoe pits. We also would like to request use of Memorial Park for the evenings of July 5, 12, 19, 26, August 2, 9, 16, 23, 30, and September 16th for the continued delivery of the Lakeside Music Series.

We would like to thank the Administration for the support they have and continue to provide as we plan this summer's events, especially with securing the insurance coverage for the events.
