Mayor Berrigan called for members of the public to speak to items on the agenda.

Karen Basset of 564 Lakeshore Drive spoke on item 9.5. and asked why the Corporate Officer had stated in his report to Council that Mr. Lanoue had created the petition when in fact it was her that created it. She wondered why Mr. O'Flaherty was calling the signatories for verification as it appeared that he was actually trying to convince the signatories to withdraw their names from the petition. She also alleged that Councillor Maki had contacted two of the signatories and wondered why she was interfering.

Laura Gebbinck of 809 Shuswap Ave. spoke on item 8.1. She is concerned by all the heavy truck traffic and the safety of bicyclists and pedestrians alike.

Brian Waterston spoke on item 8.1 and stated his opposition to adopting a bylaw that prohibits riding bicycles on sidewalks in Chase.

Mr. Swain thanked Council for inviting BC Ambulance to speak to Council. Both Mr. Swain and Mr. Silvester explained the normal call volumes for the Chase based ambulances, explaining that the Chase based ambulances are often diverted to other areas depending on the availability of resources in other communities.

Mr. Swain added that overall, the ambulance resourcing has not kept up to the demand for those services, and that results in occasional longer response times for ambulances particularly in small communities such as Chase.

Mayor Berrigan thanked Mr. Swain and Mr. Silvester for their presentation.

6.2 Brent Ashby of KPMG – 2016 Audited Financial Statements

Mr. Ashby of KPMG (Kamloops) provided an overview for Council and the public of the 2016 audited financial statements, confirming that the financial practices of the Village are performed within acceptable accounting rules. He noted that revenues and expenses in 2016 were consistent with those activities in 2015.

RE: Sanitary Sewer Regulations Amendment Bylaw No. 839-2017

It is the policy of Council, pursuant to section 9.2 of the Official Community Plan Bylaw No. 635-2002 to "provide water, <u>sanitary sewer</u> and storm drainage systems that will ensure good health and comply with recognized need, servicing standards, environmental standards and the ability of residents to pay for services."

It is the policy of Council, pursuant to section 9.3 of the Official Community Plan Bylaw No. 635-2002 to "work toward providing community <u>sanitary sewer</u> services to all urban residential areas."

The 2001 Liquid Waste Management Plan: Stage 1,2 and 3 Report references unsewered areas within the Village and the importance of working with the health authority regarding on-site septic systems. The Interior Health Authority has expressed concern over the age of many on-site septic systems in Chase, particularly in the vicinity of Paquette Road and Aylmer Road. The report states: "for the individual units and businesses to connect to this service it would require the construction of an internal collection system".

Now that the 'internal collection system' (municipal sewer system) is being extended in the vicinity of Aylmer Road, it would seem prudent for properties that benefit from proximity to this extended municipal sewer system to connect. There is currently no mechanism in Village bylaws to compel property owners to connect to a municipal sewer service. The mechanism to require connection as proposed in this bylaw is common practice across the province.

RECOMMENDATION

"That Council give first, second, and third readings to the Village of Chase Sanitary Sewer Regulations Amendment Bylaw No. 839-2017.

VILLAGE OF CHASE Bylaw No. 839-2017

A Bylaw to Amend the Village of Chase Sanitary Sewer Regulations Bylaw No. 750-2010

WHEREAS the Council of the Village of Chase has adopted the Village of Chase Sanitary Sewer Regulations Bylaw No. 750-2010;

AND WHEREAS The Council of the Village of Chase deems it desirable and expedient that owners be compelled to connect their buildings and structures to the sanitary sewer system;

AND WHEREAS The Council of the Village of Chase deems necessary to amend Bylaw No. 750-2010 to establish additional controls respecting the use of such system and to impose certain charges upon owners of properties benefiting from the opportunity to connect to a municipal sanitary sewer system;

NOW THEREFORE, the Council of the Village of Chase in open meeting assembled, enacts as follows:

This bylaw may be cited for all purposes as "Village of Chase Sanitary Sewer Regulations Amendment Bylaw No. 839-2017".

Section 3, Interpretations, is amended by adding the following definition:

"'Building' means any structure used or intended to be used in supporting or sheltering any use or habitation and includes a mobile home or any structure containing plumbing.

"'Manager of Public Works' means the person holding the position of Manager of Public Works for the Village, or a person appointed to act in their place."

Section 6 is amended by adding:

"6.9 Any property up to two (2) hectares in area within the Village of Chase on which there is located a building, and which abuts upon any Village highway, right-of-way or easement in which there is now or hereafter located a sanitary sever main, the owner is hereby required to connect that property directly to the Village sanitary sever at the owner's expense, in accordance with the British Columbia Plumbing Code and this Bylaw within thirty (30) days after notice from the Public Works Manager, and otherwise within 18 months. In the event of any owner failing to make the required connections within the specified time, the Manager of Public Works shall complete the works at the expense of such owner and the cost of work shall be deemed to be a charge for the works completed and the provisions of the Community Charter for the collection of special fees, will apply.

It is further provided that such connection will be required within thirty (30) days of being provided notice from the Interior Health Authority, if, in the opinion of the Medical Health Officer, a nuisance or health hazard exists as a result of any building not being connected to the sanitary sewer. In the event of any owner failing to make the required connections within the specified time, the Manager of Public Works shall complete the works at the expense of such owner and the cost of work shall be deemed to be a charge for the works completed and the provisions of the Community Charter for the collection of special fees, will apply.

All costs resulting from a required sanitary sewer connection shall become due and payable by the owner upon invoice. If the invoice is not paid prior to the end of the calendar year, the amounts outstanding will be transferred to the property tax account as arrears.

6.10 At such time that the Village Sanitary Sewer System becomes available to a property by abutting upon any Village highway, right-of-way or easement, and that property is serviced by a private sewage disposal system, the conditions of Section 6.9 of this bylaw shall apply. Any septic tank, cesspool, or similar facility shall then be abandoned and filled with sand or suitable material as approved by the Building Inspector."

The success of the KFAIR depends upon the support of our many community partners. We hope that we can rely on your generosity to make KFAIR 2017 a great day.



RE: Festival Society – Request for Tax Receipts for Donations

At Council's January 16, 2017 Budget meeting, the following resolution was passed:

"That the \$24,000 be taken from the Village's budget for Canada Day and Music on the Lake and re-allocated to the Chase and District Festival Society as a Grant in Aid for the purpose of funding the Canada Day and Music on the Lake events; and,

That staff be directed to provide interim reporting on the activities and expenses of the Society related to the Canada Day event and the Music on the Lake season."

Council has budgeted \$12,000 for 2017 for Canada Day festivities and \$12,000 for the Music on the Lake program. Those funds have been turned over to the Festival Society as per Council's direction, to plan, organize and manage the Canada Day event and the Music on the Lake series in 2017.

Previous Canada Day Budgets

Council budgeted \$14,700 in 2016, and \$14,400 in 2015 for Canada Day events. Village staff and volunteers planned, organized and managed the Canada Day events in 2016 and 2015. Some staff time was utilized, and all financial transactions (payments for various musical acts etc) were processed by Village office staff.

Previous Music on the Lake Budget

In 2016 (the first year of the Music on the Lake series, Council budgeted \$10,000). Financial transactions were processed by Village office staff.

In 2017, because Council has agreed to transfer the funds it budgeted for Canada Day and Music on the Lake to the Festival Society, the Festival Society will be making all the arrangements, and will be managing all the financial transactions (e.g. payment of various performers etc). The Society will also be required to fundraise for any additional funds they may need to host the event on behalf of the Village.

The Festival Society has event planning well underway. They are now asking for Council's consideration to provide tax receipts for donations to the Village of \$50 or more earmarked for Canada Day and Music on the Lake events. This will enhance their ability to fundraise additional money for expenses they will have to organize the two events on behalf of the Village.

The Director of Financial Services has been consulted and has stated that this can be done provided the funds are directed to the Village of Chase specifically for the events the Festival Society is organizing on the Village's behalf – Canada Day and Music on the Lake. A council resolution is required.

A similar arrangement has been set up for the Skatepark project, with a Council resolution having being made at Council's April 11, 2017

"THAT Council approves the issuance of tax receipts for minimum cash donations of \$50 to the Village of Chase that are earmarked for the Skatepark Project."

RECOMMENDATION

"That Council approve the issuance of tax receipts for minimum cash donations of \$50 to the Village of Chase that are earmarked for the 2017 Canada Day festivities and the 2017 Music on the Lake Series."
