4. DELEGATIONS

Dave Underwood, P. Eng, TRUE Consulting Ltd., presented his report titled *Water Supply Options for Sunshore Golf Course* before Council.

4.1 PUBLIC INPUT ON CURRENT AGENDA ITEMS

Vic Endean of 1040 Arbutus Place, regarding item 5.1, as a representative of the Chase and District Recreation Centre Society, stated that the Sunshore Golf Course has been receiving bills for water since the new rates were instituted in 2016, however so far no payments have been made to the Village for water usage as the costs for water are too high for the Golf Course to absorb without great financial difficulty. He stated that the Society doesn't really own the Golf Course, and asked if the Village wants a golf course.

Carolyn Parks-Mintz of 813 Okanagan Avenue asked the who in fact owns the golf course?

Mayor Berrigan noted that the Golf Course is currently owned by the Society.

Mr. Endean provided some history about the Golf Course, and noted that while the Society legally owns the golf course at the present time, that situation could easily change. He

added in response to a query that the Golf Course does contribute to the local economy brining in tourists to the Village.

Ms. Parks-Mintz asked if there had been any discussions with the Village regarding reduced costs for the water used at the course.

It was noted that several steps have been taken by the Village and that one of the discussions still to take place is regarding water costs for 'parks and green space'.
