A TUP allows the business operator and the neighbouring residential property owners/occupiers to "test" whether this type of commercial operation will cause disturbances in the residential neighbourhood.

I. Call to Order:

Chair Crowe called to order the Public Hearing regarding Official Community Plan Amendment Bylaw No. 915-2022 and Zoning Amendment Bylaw No. 917-2022 at 4:08 pm.

II. Opening Statement:

Chair Crowe read the opening statement for the Public Hearing noting that all persons present who believe their interest in the property is affected shall be given an opportunity to be heard or present written submissions. No written submissions were received at this Public Hearing.

III. Introduction of Official Community Plan Bylaw No. 915-2022

Chair Crowe asked the Corporate Officer to provide background information. The Corporate Officer introduced the bylaw and presented by PowerPoint. Some notable aspects of the bylaw included:

 Official Community Plan Bylaw No. 915-2022 changes the land use designation of property formerly owned by CP Rail that was erroneously designated as General Commercial.

IV. Public Input

The Corporate Officer confirmed that all statutory public notifications occurred and that there were no submissions received.

Chair Crowe called a first time for public input.

David Lepsoe, of 910 Paquette Road, asked about the ownership of the parcels affected by the amendments and the Corporate Officer indicated that Village is the owner.

Chair Crowe called a second time for public input.

Chair Crowe called a third and final time for public input.

Hearing no further input, Chair Crowe moved to the next item in the Public Hearing.

V. Introduction of Zoning Amendment Bylaw No. 917-2022

Chair Crowe asked the Corporate Officer to provide background information. The Corporate Officer introduced the bylaw and presented by PowerPoint. Some notable aspects of the bylaw included:

- Sections 8 and 64 of the Community Charter give local governments the option
 of passing a bylaw that regulates, prohibits and imposes requirements relating to
 unsightly conditions, refuse and derelict vehicles.
- Section 17 of the Community Charter provides authority for local governments to take remedial action to seek compliance of provisions.
- Zoning Amendment Bylaw No. 917-2022 amends Zoning Bylaw No.683-2006 by removing section 8(1)(a) and adding definitions of 'derelict vehicle' and 'outdoor storage'.

VII. Public Input

The Corporate Officer confirmed that all statutory public notifications occurred and that there were no submissions received.

Chair Crowe called a first time for public input.

Chair Crowe called a second time for public input.

The British Columbia Youth Parliament will hold its 94th Parliamentary Session in Victoria at the Provincial Legislative Chambers from December 27 to 31, 2022. We are hopeful for a safe return to in-person gatherings and BCYP will follow all Provincial Public Health Guidelines.

The Youth Parliament is a province-wide non-partisan organization for young people ages 16 to 21. It teaches citizenship skills through participation in the parliamentary session in December and continuing involvement in community service activities throughout the year. Youth Parliament is a one-year commitment.

I invite you to encourage eligible youth from your municipality or region to apply to sit as members of the Youth Parliament. BCYP is non-partisan, and applicants need only be interested in learning more about the parliamentary process and in serving their community. If your municipality sponsors a "youth of the year" award or has a municipal youth council, young people with that sort of initiative and involvement are ideal candidates for BCYP.

Each applicant who is accepted to attend as a member of BCYP must pay a \$425 registration fee. Thanks to private donations and fundraising, a portion of the cost of transportation and accommodation is covered for all members. We encourage municipalities or youth councils to contribute towards the application fee for applicants who are in financial need. If the approval of financial support causes any delay, we encourage the applicant to send in their forms on time along with a note saying that the cheque will arrive after the deadline. In this case, if we receive the completed form and personal statement before the deadline, it will be considered received on time. If you are not able to aid, a limited number of bursaries are available for applicants who cannot meet the expense of the registration fee. Requesting financial assistance will not affect an applicant's chance of being selected as a member. (See https://bcvp.org/session)

Members will sit and debate in the Legislative Chambers for five days and will be accommodated for four nights at the Marriott Hotel in Victoria. During that time, participants are supervised by members of the Board of Directors of the Youth Parliament of B.C. Alumni Society and other youth parliament alumni. In addition, transportation to and from Victoria will be provided for all members who require it.

I have enclosed an application form and a brochure about BCYP. I encourage you to make the application form and brochure available to interested young people and to make copies of the forms as needed. Hysop Road Lake Access

The lake access at Hysop Road between 724 and 802 Hysop has been generating some controversy for a number of years. The owner of 724 Hysop Road uses the public access to enter onto his property, and has generated vehicle traffic onto the access area by permitting boat owners to moor their boats on his private dock.

Various property owners near the lake access wish that it be left in its current state and configuration, that it should not be altered and should not restrict anyone's usage of the access. Other property owners are of the mind that vehicles should not be permitted to park near the water, and that the access be restricted to boats that do not require trailering into the water.

In May of 2016, Administration was directed by Council to further research the issues relating to the water access. A draft design for improvements and certain access restrictions was put forward to Council. The design has not been adopted. The draft design is attached.

In 2019, Council directed Administration to implement a permitting system to allow people who own or visit water access property on Little Shuswap Lake to park their vehicles overnight at both the Hysop Road and Arbutus Place beach accesses. This does not address the issues that are generating complaints from various property owners on Hysop Road: (1) Trailered boat launching; (2) Numerous vehicles and boat trailers being parked in the access; (3) Noise; and (4) Personal uses of the public space.

There is significant trespass onto the public lake access lands by the property owner of 724 Hysop Road (map attached). Additionally, this property owner uses the lands to access his property, rather than accessing from Hysop Road. Being public space, personal use and access to private property from the access should not be permitted. In addition, improvements on the access to provide for designated vehicle parking would alleviate some of the concerns of the neighbours. Trailered boat launching is a concern as there is no concrete ramp so trailers are driving directly on the lake bottom, potentially affecting fish habitat.

At the September 6, 2022 Council meeting, Council heard from a delegation of Hysop Road residents who explained their frustration with the ongoing unregulated use of the lake access, and provided a petition to Council requesting that the lake access be 'taken back' for the public, and not used for the benefit of one private property owner who operates a moorage business on his private dock. Of the 39 signatures on the petition, 33 are of Hysop Road residents.

OPTIONS

- 1. Leave the right of way as is, allowing a private property owner to benefit from the usage of public property.
- 2. Restrict access to the lake for trailered boats and vehicles by improving the lake access similarly to the draft design (placing no-posts, designating parking).
- 3. Rectify the trespass of the property owner at 724 Hysop Road and require the property owner to access his property from Hysop Road and not from the public access.
- 4. A combination of Options 3 and 4.

RECOMMENDATIONS

- (1) "That the public access to the lake between 724 and 802 Hysop Road be improved by restricting access to the lake for trailered boats and providing a specific area closer to Hysop Road for parking of vehicles."
- (2) "That the current trespass onto the public lake access by the property owner of 724 Hysop Road be rectified and that the property owner at 724 Hysop be required to access his property from Hysop Road and not the public lake access lands."


