# 5. PUBLIC INPUT ON CURRENT AGENDA ITEMS

Carolyn Parks-Mintz, of 813 Okanagan Avenue, regarding item 8.5, is in support of a rainbow crosswalk in Chase, a good location being on Haldane Street, near the appliance store.

The CAO noted that Administration has looked into costs for such a sidewalk and costs vary widely depending on the size of the crosswalk and the type of paint used to ensure its longevity – at this time there are no funds allocated. It has been suggested that if the local LGTBQ community wishes a rainbow crosswalk to be installed in Chase they can put in a formal request to Council directly.

Ms. Parks-Mintz, regarding item 10, stated support for having the Mill Park RV Park go out for a Request-for-Proposal.

Ms. Parks-Mintz, regarding item 9.3, requested a summary from Council on the history of cats within the municipality.

Councillor Torbohm addressed Ms. Parks-Mintz, suggesting municipalities are awaiting the Province to take the lead on this matter in terms of future direction and initiatives related to controlling cats.

Karen Bassett, of 564 Lakeshore Drive, regarding item 10, asked how decisions on the RV Park can be made in-camera?

The CAO responded by saying Council is fully authorized to pass resolutions at a closed meeting, and it is also appropriate.

Ms. Bassett then stated that it is unfair for Council to ask for the Lions' financial documents from the RV Park to be ready for the second Regular meeting on October this year seeing as how the request is just being put forward now.

The CAO replied that the requirement for financial document will be implemented in 2020, and this year's financials can be provided to Council before December 31, 2019.

Councillor Torbohm addressed Ms. Bassett stating the importance of the Village receiving financial information for the Mill Park RV park from the Chase Lions Club.

# 6.1 <u>Hazel Christie, Registered Professional Planner – Explanation regarding Importance of</u> having a current OCP

Ms. Christie emphasized the importance of having a current Official Community Plan Bylaw that actually serves the needs of the Village of Chase. Specifically, she pointed out that the authorizing legisation has changed significantly in 19 years and none of those changes are reflected in our aged OCP. The OCP also is very unsubstantial regarding development permit regulations specifically related to the environment. She added that current OCPs show funding agencies that the community is set up well for accepting land use applications, and may not provide grants if a document as important as an Official Community Plan is not current. Finally, she reminded Council that gas tax revenues qualify to fund much of the project.

## 6.2 Karen Bassett, Chase Lions Club - Mill Park RV Park

Ms. Bassett expressed disgust with how Council has handled renewing the lease of the RV park. She took exception to a few of the Council members alleging that they were spreading lies. She presented a petition and indicated that it provided overwhelming support for the renewing a long term lease to the Lions.
