# 8.2.4 <u>Scatchard Mountain – Proposed New Trail</u>

At its April 9, 2013 meeting, Council passed a resolution to grant \$2,500 to the Shuswap Trail Alliance to assist with the development of more trails in the Chase area, specifically the "Rocky Road" Trail on the West facing slope of Scatchard Mountain.

The proposed trail extends Southwest of the road access (the 'Switchbacks') on Scatchard Mountain. Interests in the property

include private property owners, the Village of Chase, and the Crown (Provincial).

The Shuswap Trail Alliance is now moving forward with the development of the trail, and is requiring confirmed support from the Village of Chase and neighbouring private property owners before applying to the Crown for approval.

Resolution: Moved by Councillor Lepsoe Seconded by Councillor Scott

"That Council approve the proposed route of the Scatchard Mountain "Rocky Road" Trail particularly relating to any portions of the lands in which the Village of Chase has any legal interest."
