RE: Council Procedures – Acting Mayor and Deadlines for Agendas

Acting Mayor

The Council Procedures bylaw currently requires that the Acting Mayor be appointed on a rotational basis:

"...that the Mayor appoint a roster of all Council members to serve as Acting Mayor in the absence, illness or disability of the Mayor, rotated annually so that no councillor will serve as Acting Mayor for the same quarterly period more than once during a term."

Council members who are appointed as Acting Mayor also receive based on Council's remuneration policy, \$100 per month for taking on the role of Mayor in the Mayor's absence.

Council members may wish to continue with the current requirements outlined in the Procedures bylaw or may wish to consider other options including:

- 1. Appoint an Acting Mayor for one year, allowing for each Councillor to be Acting Mayor for a full year in the 4 year term of this Council.
- 2. Appoint an Acting Mayor in the event of Mayor's absence due to unforeseen circumstances (rare) and appoint as needed an Acting Mayor for events and meetings the Mayor cannot attend due to other commitments.
- 3. Appoint an Acting Mayor as needed for events and meetings the Mayor cannot attend due to other commitments.
- 4. Maintain the status quo as per the current Procedures bylaw.

Deadlines for Agendas

It is recommended that the Procedure bylaw be amended to provide more time for Administration to prepare agendas by changing the deadline for public and other submissions of letters, requests and delegations, and that the agendas be provided to Council and the public at the same time.

The recommendation is to set the deadline for public and other submissions for an agenda at 4:00 p.m. on the Friday before the agenda is published and distributed. It is further recommended that the agendas will be published and distributed to both Mayor and Council by 4:00 p.m. on the Friday immediately following the meeting.

RECOMMENDATIONS

- 1. That the current procedures for Acting Mayor be used to appoint the Acting Mayor on a quarterly roster basis with remuneration of \$100 per month.
- 2. That the procedure bylaw be amended to provide for more time for agenda preparation and distribution to Council and the public by setting 4:00 p.m. on the second Friday before any meeting as the deadline for submissions and 4:00 p.m. on the first Friday before any meeting as the deadline for which agendas will be distributed to Council and the public.

HISTORY/BACKGROUND

Provincial enabling legislation for municipalities places several requirements on local governments in British Columbia. One such requirement is that municipalities must annually provide a schedule of its meetings, post the schedule and publish a notice indicating the schedule is available.

Meetings of Council generally take place on the second and fourth Tuesdays of each month in the Chase Community Hall at 547 Shuswap Avenue, Chase, B.C. and begin at 4:00 p.m. The attached is a schedule of meetings required by the *Community Charter* and by Village of Chase Council Procedures Bylaw No. 783-2012. Upon approval, public notice will be provided pursuant to Section 94 of the *Community Charter*.

The Council Procedures Bylaw No. 783-2012 states that Regular meetings occur on the second and fourth Tuesdays of each month except: "when a Regular meeting conflicts with the annual UBCM Convention"; "during the months of July and August when a Regular meeting will be scheduled on the second Tuesday of the month only"; and "when the fourth Tuesday falls between Christmas and New Year's".

The Union of British Columbia Municipalities (UBCM) 2023 Conference runs from September 19 to 22, 2023, which does not fall on a second or fourth Tuesday. However, the Southern Interior Local Government Association (SILGA) 2023 Conference runs from April 24 to 28, 2023, which includes the fourth Tuesday of the month. As the SILGA Conference is typically attended by Council members, Council may consider removing the April 25, 2023 Regular Meeting.

DISCUSSION

The Council Procedures Bylaw 783-2012 allows Council to hold Special meetings in circumstances when the posted schedule cannot accommodate a timely decision.

FINANCIAL IMPLICATIONS

None

POLICY IMPLICATIONS

Section 127 (1) of the Community Charter requires Council to establish and make available a schedule of its meetings and to give notice that this schedule is available.

Council has adopted the Council Procedures Bylaw 783-2012. Council has until January 15, 2023 to adopt the 2023 meeting schedule.

Dear Mayor and members of Council,

On behalf of the British Columbia Society for the Prevention of Cruelty to Animals (BC SPCA), I'd like to congratulate you on your recent election success. As **two-thirds of British Columbians are pet owners**, and many more are animal and wildlife lovers, your constituents are keen to know how you will work to create more humane communities.

As you may know, the BC SPCA has been committed to protecting and enhancing the quality of life for domestic, farm and wild animals in British Columbia for over 125 years. We operate **42 facilities and provide a range of important community services** across the province, including emergency response for pets displaced by natural disasters, compassionate pet boarding for victims of interpersonal violence, curriculum-based education programs for youth, pet food banks and low cost spay/neuter and other veterinary services. To learn more about what we accomplished last year, please see our <u>2021 Annual</u> Report.

Are you also aware of the evidence-based advocacy, policy and legislative work done by BC SPCA animal welfare experts? Our teams have contributed to recent provincial changes in rodenticide use and mink farming, reforms to national standards for animals used in research and farm animals, and advancing bills to end cetacean captivity and animal fighting. At the local government level, we have helped dozens of local and First Nation governments adopt **humane animal bylaws**.

We greatly value local government's important role in animal welfare and have support and resources to help your Council adopt enhanced animal-related bylaws for your community. Our <u>new bylaw search tool</u> provides examples of **progressive**, **BC SPCA-recommended bylaws** from communities across B.C., and we are happy to answer bylaw questions from your Council and staff.

In anticipation of this year's local government election, we surveyed BC SPCA supporters and members of the public to determine their priorities for local government action on six key animal welfare issues that you can act on or influence. We heard loud and clear that advocating to the province for petfriendly housing was their top priority: **out of the 13,865 unique survey responses that we received from B.C. residents, an incredible 9,921 people ranked increasing the availability and affordability of pet-friendly housing as a number one priority.**

The inability to find pet-friendly housing is the primary reason that adult animals are surrendered to the BC SPCA, and accounts for almost 25 per cent of cat and dog surrenders every year. Over the past eight

years, we have taken in more than 11,000 animals whose families could not find pet-friendly housing (and this doesn't include the animals surrendered to other organizations or rehomed privately)! This doesn't just affect the BC SPCA or the animals who are surrendered. Research has shown that pets improve our mental, physical and psychological health and that their unconditional love, comfort and friendship is a lifeline for many people – particularly the most vulnerable.

The pandemic and the current housing crisis have intensified the importance of pets as members of many families, and heightened the heartbreaking decisions that must be made when pet-friendly housing cannot be found. Through our outreach and compassionate boarding programs, we know that many people choose to stay in inappropriate housing, go without housing or stay in abusive situations in order to keep their pets with them.

The other animal welfare issues included in the survey also received strong public support province-wide and are key to making our communities and province a more humane place for all of us:

Creating bylaws to keep exotic animals in the wild	4,421
Restricting private use of fireworks to protect people and animals	3,825

Humanely controlling rodents by ending the use of all poisons on local government property	3,282
