Every Child Matters Crosswalk

- In support of the crosswalk and request for Kukpi7 Lynn Duck-Chief's press release to be included in the minutes of this meeting

- Recognition that we are on unceded territory of the Secwepemc people and support the crosswalk
- Concerned that this was defeated at the last meeting and had to be brought back
 a crosswalk is a good way to show our young people compassion
- Support for the crosswalk everyone should be comfortable living in our country

Water and Sewer Rates

- It is unconstitutional to charge money for water
- The Village will be receiving a bill for storing a water meter on my property
- The increase in water rates is too high too fast should be done in babysteps
- Cannot dump all these increases on the residents of our little town at one time

6.1 Kukpi7 (Chief) Irvin Wai - Neskonlith Indian Band

- Was saved from being taken to the residential school as my grandmother married a Chinese man so my last name is Chinese
- Racism is real for all of us it is hard to get out of bed every morning unsure of when one will be targeted
- Sad thing to be treated as a second class citizen in your own country
- The crosswalk is a small thing with major implications it brings awareness about the terrible experiences of the residential school system and brings closure from that awareness
- We are neighbours and friends and an outright 'No' is a slap in the face
- It takes all of us to beat racism
- A crosswalk is a visual reminder that we are all working together, moving ahead together
- We will all share in the maintenance of the crosswalk it is not just painting on the ground to us
- Thanked everyone for their time, noting there will always be hard decisions, we will not all agree on everything but we must continue to work on our relationships
- The crosswalk is a small ask and a big gesture for our people

6.2 Councillor Shelley Witsky - Adams Lake Indian Band

- In her second term on council, have worked with many groups including Chase for the betterment of the area including landmarks, trails, cultural education
- Told a story of some families who took their children into the mountains so they would not be taken away to residential schools
- An Indigenous person in the Okanagan was hidden and raised by her own family and has been very successful working towards the healing of the Indigneous people and helping to educate non-Indigenous people
- She gave the example of Osoyoos Indian Band and Chief Louis, being very successful in working with the Town of Osoyoos to enhance tourism in that region
- The four communities have discussed the crosswalk for over a year would like to see the crosswalk and murals and banners too

6.3 Nakia Hill - Summary Overview of the 2023 Summer Recreation Program

- Showed pictures from various days and activites of the program
- Average number of children was 25, the last day we had 42 children
- Some days we had to turn children away as we did not have enough staff
- We toured the police station, the Ambulance station and the medical clinic, swam in the wading pool, played at the creek, went to the beach, played games, watched movies

- The wading pool is an integral part of the program and needs some TLC
- Would like to promote this program and the need for more funding in 2024

2023 Capital Project - Shepherd Road Watermain Extension

At the June 27, 2023 Regular meeting, Council awarded the Shepherd Road watermain extension/looping project to Extreme Excavating in the amount of \$94,384.50. This important capital project provides improved water pressures and redundancy to the south-west sector of Chase.

A \$10,000 project contingency was embedded into the costs, however, due to unforeseen challenges at the project site, Extreme Excavating had to perform additional work that was not accounted for in the tendering process, and this has resulted in the need for additional project funding. The extra costs resulted from an additional required riser on the fire hydrant, extra stripping of topsoil, and an extra lateral crossing of the newly installed storm main.

This project has been funded through the Canada-Community Building fund (formerly called Gas Tax), and there is adequate funding available to fund these change orders. The entire project costs will still all be funded from the Canada-Community Building fund and not from municipal reserves and therefore will not affect taxation.

Background

In the process of setting the Five-Year Financial plan for 2023-2027, it was anticipated

that this project would cost \$85,000. When the tender documents were received and reviewed, it was discovered that the quoted bids all came in higher with Extreme's bid being the lowest at \$94,384.50.

Utilizing funds from the Canada-Community Building fund is the logical and most responsible option. The Village's uncommitted portion of the reserve fund for the Canada-Community Building fund will be \$753,186 after this draw down.

Municipal Sewer Main Extension - 845 Thompson Avenue

ISSUE/PURPOSE

To provide Council with additional information related to a property owner's request to have the Village install 65m (213 ft) of municipal sanitary sewer main works in order that a private residence can connect to the municipal sewer service and abandon their septic sewer system.

DISCUSSION

Through legal advice, we have already established that the Village is not legally obligated to extend the sewer main to allow a property owner to connect to its sanitary sewer system. The Village actually has the authority to require the Owner, at their expense, to install the additional infrastructure to enable the connection to the sewer system.

Staff performed an extensive sweep of all records related to the site and successfully uncovered the architectural drawings for the ambulance station that Interior Health (IH) provided. The site plan for the ambulance station shows that the 100mm sanitary sewer service for the ambulance station connects to the service line for the Health Centre.

It is highly irregular, and contrary to MMCD standards to connect a service line into and through another service line that ultimately connects to a main line. Services must connect directly to a main line. Plus, even of this was a standard practice, agreements would need to be struck between IH and the Behrns as IH would be agreeing to accept sanitary sewer waste from the Behrns.

Staff did acquire the quote provided from a contractor to the landowner that amounts to a little over \$11,000 but does not include asphalt replacement. It is important to verify that any infrastructure work proposed and priced accordingly is engineered under MMCD standards, as the Village will ultimately own, repair, and replace said infrastructure.

FINANCIAL IMPLICATIONS


The estimate of costs for the MMCD infrastructure works is \$59,966. There is an additional \$325 sewer connection charge as per the *Village's Fees & Charges Bylaw*.

A 2023 capital budget amendment is necessary if this project is borne by taxpayers.

ISSUE/PURPOSE

The purpose of this report is for Council to consider authorizing a new retail cannabis sales licence at the subject location.

OPTIONS

- 1. Support of a new provincial primary license
- 2. Support of a new provincial primary license with conditions
- 3. Do not support a new provincial primary license

BACKGROUND

The proposed licence location at 560 Shuswap Avenue is zoned C-2, Downtown Commercial. Cannabis Retail is a permitted use in this zone. The applicant is proposing to utilize an existing commercial space to operate a new retail cannabis business and requires a business licence to conduct business.

DISCUSSION

Council is being asked to support the applicant, Sundeep Mahal, of Barriere Budz Cannabis, with his application to the provincial regulator, the Liquor and Cannabis Regulation Branch (LCCRB), in order for his application to proceed. Mr. Mahal requires a provincial licence first, before he is able to apply for a Village of Chase business licence, and ultimately operate his business. The LCCRB has completed its assessment of the eligibility and suitability requirements of the *Cannabis Control and Licensing Act* and now requires a Council resolution for the new proposed retail store in order to issue the required licence, per provincial requirements.

REFERRALS

The RCMP were referred to on August 17, 2023 and no reply has been received indicating their interests are unaffected.

A letter has been sent to all properties within 50m of the subject property. No responses have been received as of the date of this report.

FINANCIAL IMPLICATIONS

An application fee of \$1000 was paid for this application. A Cannabis Retail business license is \$500.

POLICY IMPLICATIONS

POLICY:

Regulations applicable to all Business License applications within the Village of Chase.

PURPOSE:

To set guidelines and direction for receiving and processing Business License applications for controlled substances including cannabis and liquor. The Province of British Columbia has determined what they consider to be acceptable content and acceptable form of local government input on liquor and cannabis license applications.

Therefore, the Village of Chase has developed the following policy to outline the process by which Council shall review, evaluate, and provide input on liquor primary, food primary, and special occasion liquor license and retail cannabis license applications in the Village of Chase.

DEFINITIONS:

BUSINESS LICENCE means a document issued in accordance with Business License Bylaw 735-2011 or its replacements, authorizing the carrying on of a commercial or industrial undertaking of any kind or the providing of professional, personal or other services for the purpose of gain or profit whether only based within the Village of Chase or actually operating within the Village, and shall include subsidiary operations which are a demonstrably integral part of the principal Business. Individually licensed businesses shall be differentiated by type of business irrespective of joint ownership or co-location.

CONTROLLED SUBSTANCE means a substance included in Schedule II of the *Controlled Drug and Substances Act* of Canada, 1996 chapter 19, as amended from time to time, and includes ethyl alcohol as defined in the *Liquor Control and Licensing Act* of BC.

VILLAGE means the municipality of the Village of Chase.

APPLICATION PROCEDURE:

- 1. All applicants shall complete the application form as per Schedule A and submit payment. The Village of Chase will not accept applications that do not contain the following information:
 - The name, address, and signature of the applicant;
 - The name and address of the property owner and the signature of the property owner consenting to the application;
 - The legal description and street address of the subject property;
 - Receipt of a copy of a completed LCRB application form (for new applications);
 - For temporary amendments to a License, applications must be submitted no less than 6 (six) weeks prior to the requested date to be considered;
 - Application fee;

- Type of application being made:
 - i) Application for a New Controlled Substance License;
 - ii) Application for an Amendment to Existing Controlled Substance License;
 - iii) Application for a Food Primary License;
 - iv) Application for a Temporary Amendment to a Liquor License;

LOCAL GOVERNMENT RESOLUTIONS

2. Council may pass a resolution based on a specific term or condition; however, prior to doing this Council shall ensure that the term or condition is within the legislative jurisdiction of the Liquor and Cannabis Regulations Branch (LCRB) to impose or enforce.

Council may decide through a resolution, to:

- a) Support of a new provincial primary license
- b) Support of a new provincial primary license with conditions. These conditions may include a restriction on hours, or imposing landscaping requirements
- c) Not support a new provincial primary license

Administration will undertake the following procedures to gather the opinion of nearby residents:

- a) Require the application to submit a *Controlled Substance License Application* as per *Schedule A* along with the requisite fee. Applications will be processed in the order that referrals are received from the LCRB.
- b) Advise all property owners in writing within 50 metres of the proposed location and provide a 10-day time limit to receive any feedback.
- c) Refer the LCRB application to the RCMP
- d) Prepare a report to Council containing all feedback from residents, the RCMP, and include technical comments from Administration
- 3. Upon completion the resolution or comment shall be forwarded to the LCRB, the applicant, and the License Inspector.

APPLICATIONS FOR NEW CONTROLLED SUBSTANCE LICENSE (\$1,000.00 Application Fee)

4. The Village will provide written notification to owners or tenants in occupation of the parcels which are the subject of the application, and all parcels within a distance of 50 metres from the land that is the subject of the application at least 10 days prior to the date on which Council will consider the application. The notification shall advise the public of the nature of the application and may include the proposed seating capacity and hours of operation and indicate that there is an opportunity to be heard by Council at a hearing.

The Village shall advertise in the local newspaper, the publication to appear not less than 3 and not more than 10 days before the date of the hearing before Council on the application. The advertisement shall advise the public of the nature of the application, and their opportunity to be heard by Council at a hearing.

Where an application for a local government resolution is associated with an application for rezoning to permit the licensed establishment, the Public Hearing for the rezoning shall be used to obtain public input. Where no rezoning is involved, Council shall hold a hearing to obtain public input that shall be advertised as noted above.

Reports to Council regarding controlled substances licenses shall include technical information from Administration relevant to the following issues, which the LCRB requires Council to consider and comment on in their resolution:

- The location of the establishment;
- The proximity of the establishment to other public facilities;
- The hours of service;
- The seating capacity (only for liquor primary);
- Traffic, noise, parking and zoning;
- Population, density, and trends;
- Relevant socio-economic information; and
- The impact on the community if the application is approved.

The Corporate Officer shall refer all applications to the RCMP for comment prior to preparing the report for Council.

APPLICATIONS FOR AMENDMENTS TO EXISTING CONTROLLED SUBSTANCE LICENSE (\$300.00 Application Fee) (Occupant Load Increase, Winery Endorsement, Permanent Hour Extension)

5. The Village will provide written notification to owners or tenants in occupation of the parcels, which are the subject of the application, and all parcels within a distance of 50 metres from the land that is the subject of the application at least 10 days prior to the date on which Council will consider the application. The notification shall advise the public of the nature of the application and the existing operation, and their opportunity to be heard by Council at a hearing.

On the date identified in the public notice Council will hear the applicant and any other person deemed to be affected or having an interest in the application.

Reports to Council regarding new liquor primary or cannabis retail licenses shall provide information relevant to the following issues, which the LCRB requires Council to consider and comment on in their resolution:

- The location of the establishment:
- The proximity of the establishment to other public facilities;
- The seating capacity and hours of service;
- Traffic, noise, parking and zoning;
- Population, density, and trends;
- Relevant socio-economic information; and
- The impact on the community if the application is approved.

The Corporate Officer shall refer all applications to the RCMP for comment prior to preparing the report for Council.



FOOD PRIMARY LICENSE APPLICATIONS (\$300.00 Application Fee) (Late Night Hour Extensions Beyond Midnight and Patron Participation Entertainment)

6. The Village will provide written notification to owners or tenants in occupation of the parcels, which are the subject of the application, and all parcels within a distance of 50 metres from the land that is the subject of the application at least 10 days prior to the date on which Council will consider the application. The notification shall advise the public of the nature of the application and the existing operation, and their opportunity to be heard by Council at a hearing.

On the date identified in the public notice Council will hear the applicant and any other person deemed to be affected or having an interest in the application.

Reports to Council regarding new controlled substance licenses shall provide information relevant to the following issues, which the LCRB requires Council to consider and comment on in their resolution:

- The potential for noise if the application is approved;
- The impact on the community if the application is approved;
- Whether the application will result in the establishment operating in a manner contrary to the primary purpose of the establishment, which is the service of food

The Corporate Officer shall refer all applications to the RCMP for comment prior to preparing the report for Council.

TEMPORARY AMENDMENTS TO LIQUOR LICENSES (\$100.00 Application Fee) (Special Occasion Hour Extensions or Temporary Occupant Load Increase) *Applications must be received no less than 6 (six) weeks prior to requested date(s) to be considered.

7. Applications for a temporary amendment to a Liquor Primary or Food Primary License, which require local government comment shall undergo the following process.

At a Council meeting or a Committee of the Whole meeting where a resolution is to be considered, the Corporate Officer shall present a comprehensive report and draft resolution for the Council's consideration. The report to Council shall provide information relevant to the following issues, which the LCRB requires Council to consider and comment on in their resolution:

- The potential for noise if the application is approved;
- The impact on the community if the application is approved;

The Corporate Officer shall refer all applications to the RCMP for comment prior to preparing the report for Council.
