During discussion the following points were raised:

- While the cost will be low to install, the Village will be responsible for the costs of annual maintenance
- Maybe there are other options that won't be subject to vandalism and will cost less for annual maintenance
- There is no quote provided and this is just a political statement
- Maybe it could be painted on a wall
- Another option could be banners downtown
- You don't see a crosswalk in Adams Lake's community
- The majority of taxpayers do not want a crosswalk
- Short-sighted not to do this a small cost for big gains in our relationships with the three local Indigenous communities
